Located about an hour's drive from Tucson within the Coronado National Forest, Kentucky Camp is one of the few well-preserved "ghost towns" in southeast Arizona open to the public.

**T**he *Friends of Kentucky Camp* offer members hands-on experience in historic preservation and interpretation, in a beautiful setting and a congenial atmosphere:

- Organize public "volunteer days" on the second Saturday of each month
- Work with specialists in earthen architecture and conservation
- Repair/reconstruct woodwork, electrical and water systems
- Conduct archival and oral history research
- Provide on-site caretaking

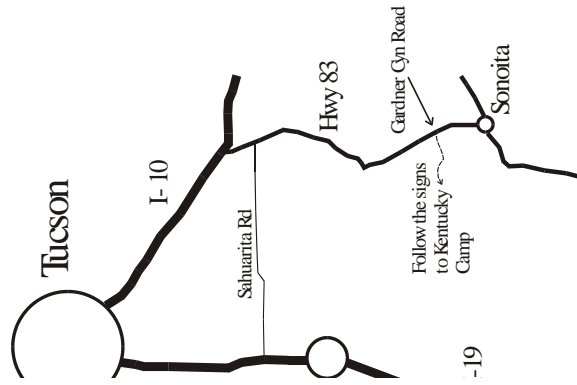
